Purchase Terms, Conditions and Policies

Ticket purchaser agrees to all of the following terms and policies:

- 1. Bristol Fourth of July Committee credit card processing** - The payment processing services for services and/or goods purchased on this website are provided by authorize.net depending on your location and/or the type of payment method used for the purchase of the services and/or goods. If you are using your credit card to purchase tickets in the United States, your payment will be processed through an acquirer based in the United States, and you are agreeing to the following terms and conditions set for by Bristol Fourth of July Committee below.

- 2. Bristol Fourth of July Committee** - For purposes of these terms, conditions, and policies, are subsequently referred to together as the Committee. The Committee is not affiliated with any event producers or others providing services or events (“producer”) for which tickets are purchased. The Committee assumes no liability incidental to the event for which tickets are sold or purchased. Ticket purchaser assumes all risks associated with attendance of events.
- 3. Ticket Delivery** - Ticket delivery options are event specific and are determined by producer. Event specific delivery options are listed on the Bristol Fourth of July Committee website. Ticket purchaser assumes all risk of ticket loss, theft, delay, damage, or destruction during delivery of tickets. Tickets lost, stolen, delayed, damaged, or destroyed during delivery will not be replaced.
- 4. Will Call List** - Ticket purchasers choosing to redeem ticket orders via the event Will Call List will not receive paper tickets in advance. Tickets or event entry can be redeemed at event venue box office or point of entry unless otherwise instructed. PHOTO IDENTIFICATION and the ORIGINAL CREDIT CARD used to make the purchase must be presented in order to redeem tickets and/or entry into event. Refunds will not be granted if ticket purchaser fails to appear for Will Call List entry, or fails to provide photo identification and/or the original credit card used to make the ticket purchase. Ticket purchaser understands and agrees that ticket purchaser’s name, city and state of residence, and a portion of ticket purchaser’s credit card number will be released to producer and venue in order to ensure ticket purchaser identity.
- 5. Canceled/Rescheduled Events** - Producers or others outside the control of Bristol Fourth of July Committee may cancel or reschedule events. It is at the producer’s discretion whether to refund the ticket price or exchange the tickets for a similarly equivalent event should a cancellation or rescheduling occur. Bristol Fourth of July Committee will provide instructions on its website on how to exchange event specific tickets, or obtain ticket price refunds, should an event be canceled or rescheduled. Service charges and mailing costs will not be refunded in the event of a canceled or rescheduled event.

6. Pricing, Availability and Seating

- Event ticket prices are set by the Bristol Fourth of July Committee. For most ticket sales in the United States and for events with ticket sales in U.S. Dollars, the Bristol Fourth of July Committee service fee is US\$0.99/ticket, plus up to 3.5% of the face value of each event ticket. There may be certain events for which Bristol Fourth of July Committee service fees will be higher, and/or times when a separate venue fee may be added by the event organizer or the venue.
- The number of tickets sold for an event is set by Bristol Fourth of July Committee. Should tickets be oversold by the producer, the producer has discretion as to the method of refund, including but not limited to event price refund, or ticket exchange for a similarly equivalent event. Should over sale occur, only whole, non-perforated tickets will be refunded or exchanged.
- Venue seating charts are provided by Bristol Fourth of July Committee only as a representative of the venue. Bristol Fourth of July Committee is not responsible for incorrect seating information, or ticket holder dissatisfaction with selected seating. Service charges and mailing costs will not be refunded if event tickets are oversold, or if a ticket purchaser is dissatisfied with selected seating.

7. **Lost, Stolen, Destroyed Tickets** - Lost, stolen, delayed, damaged, or destroyed tickets will not be replaced or refunded, including tickets lost, stolen, delayed, damaged, or destroyed during delivery to ticket purchaser.
8. **Refunds and Exchanges** - All sales are final. Please review ticket ordering information carefully prior to ticket purchase. Bristol Fourth of July Committee will not refund or exchange tickets.
9. **Privacy Policy** - There may be events for which we may require the personal information of the ticket purchaser. For other events, the producer will give the option to ticket purchaser at the time of ticket purchase to provide the ticket purchaser name and contact information, including mailing address, email address, and telephone number, to event producer.
10. **Order Cancellation** - Bristol Fourth of July Committee reserves the right to cancel ticket orders for any reason, not limited to incorrect billing information and/or fraudulent ticket purchasing.
11. **Resale of Tickets** - Tickets purchased through Bristol Fourth of July Committee are for individual use only and not for resale. Resale will automatically void tickets, barring refunds, exchanges, and entry into event.
12. **Disputes** – If any dispute arises, including regarding a transaction paid with a credit card in the United States, the dispute will be governed by the State of Rhode Island.
13. **Effective Date** - These terms, conditions and policies are effective as of May 15, 2018.
